<u>Draft Minutes of the Annual Meeting of Marbury and District Parish</u> Council

- 1. Apologies. Apologies from Cllr J David, Cllr J Gibbins, Cllr G Drinkwater were approved and accepted.
- 2. Chairman steps down.
- 3. Election of Officers for 2018/2019
- a)Chairman. It was proposed by Cllr Briggs and seconded by Cllr Shakeshaft to elect Cllr R Perry as Chairman for 2019/2020. Cllr Perry took the Chair and acted as Chairman for the rest of the meeting.
- b)Vice-chairman. Deferred until the next meeting.
- 4. Election of representative to other organisations. Cllr Turnbull will continue as a representative of the Parish Council at the Police cluster meetings. Cllr Makin will continue as the representative on the Village Hall Committee. The cemetry board was discussed but no decision was made.
- 5. Declarations of interest. No declarations of interest.
- 6. Minutes of previous meeting. It was proposed by Cllr Shakeshaft and seconded by Cllr Briggs to accept and approve the minutes of the meeting on the 11th March 2019 as a true record. The Chair signed the minutes.

- 8. Public speaking time. No members of the public present.
- 9. Matters arising
- a) Badgers on Wirswall Road. Cllr Shakeshaft met with Roy Cook who confirmed that the survey will start in June.

ACTION: Clerk to ask Roy Cook for an update.

b) Horse riding signs. The changes requested have not been actioned by Cheshire East Council. The Clerk has sent three copies of the map into the Council. Roy Cook during his tour of the village said that horse riding signs are put in place where the numbers of horses are highest. Cllr Makin disagreed that the signs should be placed before points of danger. ACTION:Clerk to email Cheshire East Council for an update.

c) Play area. Cllr David between meetings has investigated the price of upgrading the roundabout. The Clerk has a meeting for funding in Winsford with a representative form Cheshire Leader Fund to discuss a grant.

ACTION:Clerk to attend meeting with Cheshire Leader Fund representative.

d) Neighbourhood Plan. No progress has been made on this matter as no leader or potential members have come forward.

ACTION:Cllr Turnbull to arrange for David Craig from Wrenbury Parish Council to do a short presentation at the next meeting.

e) Finger posts. Nothing to report.

ACTION: Cllr Briggs will contact George Edge to see if he has done the cleaning of the posts.

f) Standing orders and financial regulations review. This still has not been read by all Councillors.

ACTION: All Councillors to read the documentation. The Clerk will distribute the paperwork to the new Councillors.

- g) Passing places. It was proposed by Cllr Shakeshaft and seconded by Cllr Wilson to remove this item off future agendas as only one member of the public has reported passing places as an issue. There are numerous sites in the locality which would benefit from improved passing places but this is not financially possible based on the money received from the precept.
- h) A49 safety issues. No progress has been made on this matter. Roy Cook confirmed that a road closure would be required for line painting and the painting would only be done in conjunction with another Highways issue.

ACTION:Cllr Davies to look into this matter further with Cheshire East Council. Cllr Wilson will encourage neighbours to report their concerns and sent details of their complaint to the Clerk to compile a record of events.

- i) Resurfacing of Bradley Green Lane. No progress has been made. Roy Cook confirmed they are currently waiting for funding for this project.
- j) Broadband. Cllr Perry has poor broadband in Norbury and is interested in finding out more about G-fast. Cllr Chapman noted that when filling out an online form using his phone number that it suggested that broadband would be in his area in the next 3 months.
