- **1. Apologies were received from** Councillor A Ashton, Councillor P Chapman, Councillor J Gibbins, Councillor R Perry and Councillor P Shakeshaft.
- **2. Declarations of interest** Councillor F Wilson made a Declaration of Interest regarding Planning Application 22/0785N.
- **3. Public Speaking Time -** A resident discussed the noise created by a function in a field adjacent to Wirswall Road.
- **4. Minutes of previous meetings –** The Minutes relating to 17th May 2022 were APPROVED and AGREED by Councillors whereby Councillor Marian Turnbull proposed and Councillor John David seconded them. As per procedure they will also be reviewed at the next AGM.

The meeting dates were discussed with the Councillors and they will be AGREED by the Councillors before the next meeting in September 2022.

6. Matters Arising

- a) Election of representatives to other organisations (such as Pan Highways representatives) To bring forward to the next meeting.
- b) Neighbourhood Plan There was no update.
- **c) Cemetery -** Councillors were informed that Whichchurch Town Council were setting up an Advisory Group. No representatives were put forward at this point in time.
- **d) Update of Pan Parish Highways -** There was no update. Cllr. John David pointed out that drains on Wrenbury Road needed repair; Fix My Street app was working.
- e) Cheshire East Enhanced Partnership Plan & Scheme Consultation The Clerk will provide feedback regarding the consultation. Comments were made about public transport providing access only within Cheshire, none for access to local doctors, hospital, etc. at Whitchurch. The GoToo service seemed to be useful but was not used enough, partly because of lack of drivers; a 3-year trial would not be representative if the service was not working properly.
- **f) Have your say on access to the countryside** advisory group- No representatives were put forward at this point in time.
- **g) Badgers on Wirswall Road** Borough Councillor Davies stated that the money and workforce were available, awaiting United Utilities' input.
